NPA Introduction to Diamonds for Pawnbroking -6 modules

The seven new modules are simple to follow, and should take around 30 minutes a module – something that can be fitted in during a quiet period in the day (we hope you don't have too many of these in your stores!), and built up to complete the course. It serves as an excellent introduction for new or inexperienced staff as well as a useful revision for those of you who have been doing this for years. It also acts as the foundation for a new module due to be released for the Certificate in Pawnbroking in October 2020, which covers more advanced topics for those experienced in diamonds identification and assessment.

5 4C's Clarity
6 4C's Carat 10 question from database on subject, certificate available.

The topics and content cover the essentials of what is needed on a daily basis to provide an excellent pawnbroking service on diamonds efficiently to your customers.





NPA Pawnbroking Certificate in Diamonds -10 modules

Having studies the introduction modules, the next progression is to the full NPA Certificate. The course develops skills, knowledge and understanding to a greater degree, covering the topics in more detail. Staff should be able to judge diamonds more efficiently, effectively, and responsibly and be even better placed to lend against diamonds to grow your business.

Details of the new Certificate in Diamonds Courses

There are ten modules including a half hour online exam. At the end of each module there is a short test against the clock comprising 10 randomly generated questions. The certificate for each module can be printed as evidence of passing that module. Once all modules are completed and passed the student is ready to sit the main exam with 50 randomised questions to answer. Once passed they will gain the NPA Certificate in Diamonds qualification. The modules cover.

- 1) Understanding and using diamond reports
- 2) Reviewing and recognising special treatments
- 3) Identifying synthetics
- 4) Understanding and establishing carat
- 5) Recognising and interpreting colour
- 6) Analysing clarity
- 7) Recognising different cuts
- 8) Understanding and evaluating fluorescence
- 9) Interpreting price and understanding value.
- 10) Final exam.
